

Terms & Conditions for Use of Certification Logo & ACB Symbol

1. Use of Certificate

- The certificate is valid only within the defined scope of certification and during its validity period.
- The certificate and related rights are non-transferable. Clients must not authorize third-party use.
- Clients may reproduce the certificate (e.g., photocopy or scan) for publicity or verification. Reproductions can be in full color and do not require watermarks.
- All certificates remain the property of Synergy Certification Sdn Bhd and must be returned immediately upon suspension, termination, or withdrawal of certification.

2. Use of the Certification Logo

The certified organization shall use the certification logo with the following conditions:

- Clearly indicate the certified scope and avoid implying certification for non-certified operations.
- If there is reduction of certification scope, all marketing materials must be promptly updated.
- Use of the certification logo shall be discontinued immediately upon certification suspension or termination.
- The certification logo shall not be altered, and any resizing shall maintain its original proportions.
- Certification logo rights are non-transferable, even during company ownership changes, without Synergy's written approval.
- of client and no such claim shall be made.
- The certification logo is allowed to be used in the following area:
 - Official letterheads and corporate stationery.
 - Marketing and promotional materials.
 - Signage identifying company premises or facilities identification.
 - Vehicles (e.g., fleet or delivery) and transport packaging provided that the use clearly relates to certified management systems.
- The certification logo is not allowed to be used in the following area:
 - On products or primary product packaging or in a way that may be interpreted as product certification or product conformity.
 - Test & calibration laboratory management system certification (ISO/IEC 17025) is not equivalent to Accreditation Certification Body (ISO 17021) as such Synergy's logo shall not apply in testing, inspection or calibration report of client and no such claim shall be made.

3. Referencing the Certification

- Clients may only claim certification related to approved processes or activities.
- Do not imply that Synergy Certification has approved or certified a product.
- When referring to certification without using the certification logo, use the following format:
 - Certified in [name of the standard]– by [Certification Body], [cert number].

Example statement by schemes:

- **ISO 9001:2015 (QMS)**
Certified in ISO 9001:2015 Quality Management System – by Synergy Certification Sdn Bhd, [SCQ XXXX].
- **ISO 14001:2015 (EMS)**
Certified in ISO 14001:2015 Environmental Management System – by Synergy Certification Sdn Bhd, [SCE XXXX].
- **ISO 45001:2018 (OHSMS)**
Certified in ISO 45001:2018 Occupational Health & Safety Management System – by Synergy Certification Sdn Bhd, [SCO XXXX].
- **ISO 22000:2018 (FSMS)**
Certified in ISO 22000:2018 Food Safety Management System – by Synergy Certification Sdn Bhd, [SCF XXXX].
- **MS 1480:2019 (HACCP)**
Certified in MS 1480:2019 Hazard Analysis & Critical Control Point – by Synergy Certification Sdn Bhd, [SCH XXXX].
- **MS 1514:2022 (GMP)**
Certified in MS 1514:2022 Good Manufacturing Practice – by Synergy Certification Sdn Bhd, [SCG XXXX].

4. Use of Accreditation Certification Body (ACB) Symbol

- The ACB Symbol shall always appear together with the Synergy Certification logo.
- Do not imply that ACB (e.g. Standards Malaysia) has certified, endorsed, or approved any product, system, or organization.
- Synergy Certification Sdn Bhd shall verify compliance with these requirements during regular surveillance audits.

On Buildings or flags.	Not Allowed
On Internal office walls and doors.	Allowed
On Exhibition booths and displays	Allowed




Figure 1: Synergy Certification logo & ACB symbol
